(registration seat: U Rustonky 714/1, Karlín, 186 00 Prague 8, Czech Republic; registration number: 073 33 528, "CSG") as the Buyer entered into a share purchase agreement for the seller's shares in 4iG SDT EGY Zrt. (registered seat: 1013 Budapest, Krisztina körút 39.; registration number: 01-10-143379; a "Target Company"), representing 49% of the share capital of the Target Company. As a result of the share purchase agreement, CSG became a shareholder of the Target Company. Furthermore, given that the Target Company is a shareholder of Rába Automotive Holding Plc. (registered seat: 9027 Győr, Martin út 1.; registration number: 08-10-001532; a „Rába”) the Target Company acquired indirect control in Rába by crossing the 35% threshold on September 2, 2026.
